## **ILG Frontier Airlines Update**

The COO reported that as of the end of 2013, Frontier Airlines has been operating at the Wilmington New Castle Airport for six (6) months and currently has five (5) non-stop destinations, including Fort Myers which began on November 16. Customer booking and travel response has been strong, particularly during the holidays and that flights were operating in 90-95% load range. Comments we receive in-person and from customers on social media have been equally favorable about the service. The COO also identified that the airport was faced with many weather challenges during December and was pleased to report that although some flights were delayed, no Frontier flights were canceled. He indicated that Frontier has been receiving high marks for its internal measures of customer service and on-time performance at its Wilmington New Castle station. Finally, the COO stated that DRBA staff will continue to monitor the airline since the sale to Indigo Partners, and that we see no sign of a shift in strategy or focus that would change the current operation at New Castle.
