- 1. Committee Chair Bennett opened the Budget & Finance Committee meeting at approximately 9:02 a.m. The Deputy Executive Director (DED) reported that the public meeting of the Budget & Finance Committee had been duly noticed in accordance with the Authority's Freedom of Information Regulations, read the Statement of Notice, and called the roll.

#### 3. Action Items:

# • RESOLUTION 19-01 – ADOPTS A REVISED TOLL SCHEDULE FOR THE DELWARE MEMORIAL BRIDGE

The Chief Financial Officer (CFO) presented and highlighted the proposed toll rate structure including the creation of the E-ZPass passenger vehicle rate of \$4.75 and revision to the frequent traveler rate of \$2.25. The CFO noted an estimated impact of \$1.25 million reduced revenue from the last toll proposal for home agency E-Zpass transactions and \$350,000 impact for the Frequent Traveler rate adjustment. The CFO noted that the \$1.6 million loss in potential revenue triggered a modified CIP which Mr. Meconi will review in the Projects Committee. Overall, the revised toll structure will generate \$32 million in new revenue for the Authority.

Commissioner Ratchford made a motion, Commissioner Smith seconded, and the Budget & Finance Committee recommended forwarding the Resolution to the full Board for approval. The Resolution will be presented to the full Board for consideration at the February meeting later today.

# • RESOLUTION 19-02 – AUTHORIZING AUTHORITY EXPENDITURES PURSUANT TO RESOLUTION 01-84 FOR THE PERIOD, JANUARY 1, 2019 THROUGH DECEMBER 31, 2019

The CFO advised US Foods is no longer under state contract. The CFO discussed temporarily waiving procurement threshold for immediate purchases placing US Foods on the over 25 resolution. Staff will begin evaluating and identifying primary food sourcing needs and recommended creating a modified publicly bid criteria that will consider factors beyond the lowest bid by incorporating factors such as quality and ability to deliver food services. In addition, the CFO noted the desire of the food service department to identify local sourcing alternatives for items such as fresh produce, meats and other products. Commissioner Bennett noted his support for creating an approved list of alternative food sources. Staff will return with these action items for committee review as soon as possible.

Commissioner Smith made a motion, Commissioner Ratchford seconded, and the Budget & Finance Committee recommended forwarding the Resolution to the full Board for approval. The Resolution will be presented to the full Board for consideration at the February meeting later today.

• RESOLUTION 19-03 – ADOPTION OF A REVISED FARE SCHEDULE FOR THE CAPE MAY-LEWES FERRY TO INCREASE VEHICLE FARES, DECREASE PASSENGER FARES, AND TO INTRODUCE OTHER FARES SUCH AS" A "BLUE & RED" DISCOUNT FARE FOR FIRST RESPONDERS

The purpose of this Resolution is to repeal Resolution 18-52 and authorize adoption of a modified Delaware River and Bay Authority 2019 Capital Improvement Program (CIP) investment proposal, in the amount of \$84,810,000.00 in Authority Funds and \$19,265,000.00 in external funds, for a total of \$104,075,000.00.
