This position is a casual maintenance landscaping and custodial position. Most job responsibilities require little or no previous skills. This position is required to operate basic hand tools and light equipment. This position is also required to work safely and efficiently in accordance with instructions, general operating practices, and procedures. Work is focused on immediate unit with limited awareness of related areas. This is predominately a Monday through Friday 7a-3p shift, but Work schedules can be modified to fit the departmental needs which may require the employee to work shift work and/or weekends. Work is performed outdoors and can be in any weather condition. This casual position is part-time and there are no guaranteed minimum number of hours, nor are there any guaranteed assignments.
